GOALS:

The purpose of the contest is to support talented children, youth and adults.

This is a unique contest that gives soloists and groups an opportunity to evaluate creativity by a highly professional international jury. Without going abroad, participants receive international diplomas and appreciation letters for their teachers and accompanists.

Distance participation via Internet motivates creative groups and soloists to new successes and creativity. Participation in this contest also promotes patriotic education and national identity - participants represent their country's culture at international level. Preparation for the contest gives teachers new ideas, gives participants new inspiration, higher level of stage skills and experience.

CATEGORIES:

- dance (folk dance / stylization, classical/ballet, jazz, pop, street dance, contemporary dance/modern, dance theater, sports dance and others);
- instrumental art (groups, duets, soloists);
- vocal (pop, folk, classical, jazz, rock, musical, choir);
- circus art, artistic gymnastics;

- fashion theater, modeling;
- visual arts (painting, graphics, drawing, decorating art);
- theater, small theater forms, recitation;
- and others (please verify with organizers)

AGE CATEGORIES:

DEBIUT — up to 7 years old

MINI- 8-11 years old

MIDI- 12-14 years old

MAXI — 15-18 years old

MAXI PLUS — 19-22 years old

EXTRA — 23 years and older

MIX — mixed category (all groups except for EXTRA)

EXTRAMIX - mixed category including category EXTRA (for example, teacher + student)

PARTICIPATION DONATION for every category:

- solo — **48 PLN (11euro)**
- duet/trio — **65 PLN (15 euro)**
- small formations 4-7 participants - **96 PLN (2 euro)**
- groups 8-12 participants — **144 PLN (33 euro)**
- ensembles 13 and more participants — **192 PLN (44 euro)**

Participants from groups of interest, teams from schools, cultural centers and other cultural or educational institutions can participate in the contest. Soloists and groups without age limits can also apply individually (independent participants).

REPERTOIRE OF FREE CHOICE:

- Solo/Duet / Trio / Small Formations – 1 piece up to 5 minutes;
- Groups and Ensembles – 1 piece up to 5 minutes;
- Theater – performance or part of it up to 15 minutes;
- Visual arts – 1 piece (various styles and techniques are acceptable) –

Topic „Autumn Glow”

The performances can be accompanied by "live" music or recorded music. The use of playback by vocalists during performances is prohibited. Studio videos and videos with backvocal could be moved to the category „video clip”

EVALUATION:

Jury evaluates participants' choice of repertoire, skills, artistry, selection of costumes and props, general artistic expression.

Jury evaluates participants individually according to age category and depending on the category of the institution (for example, half-professional participants from music school are not compared with participants from the community cultural center).

Evaluation system - points (so-called qualification, not competition between participants).

CONDITIONS FOR ONLINE CONTEST APPLICATIONS:

1. The Organizer considers video recording sent via links to **youtube** (without viewing restrictions!). Do not delete applied video recording until you receive a diploma and general results published.
2. The video recording must not be edited (no special effects, unless the category requires that). Modified video could be moved to the category „video clip”.
3. The video should be recorded using a tripod, in high quality, without acoustic interference or gaps.
4. The video should be recorded on stage, in the auditorium, class or other suitable room. **Home Videos for some categories are also acceptable.** The videos should be of good quality.
5. Instrument, hands and face of the performer must be clearly seen.
6. The stage costume is required.
7. Video recorded during another event, competition or concert is allowed.
8. Unprofessional video recorded with a mobile phone is allowed, but it should be of good quality with clear sound.
9. Dance categories: the video should be recorded as a general plan to make the entire choreographic layout visible.
10. Performances are allowed in any language.
11. Visual Arts - photos or scans of works are sent to digitalenty.pl@gmail.com
12. Participants are responsible for compliance with copyright and related rights.
