



REGULATIONS OF INTERNATIONAL ART EXHIBITION

"TALENTS TOGETHER – COLORS OF DIVERSITY"

1. DESCRIPTION OF THE EXHIBITION

The international exhibition **"Talents Together – Colors of Diversity"** will take place in Autumn 2026. The aim of the event is to present the talents of children, youth and adults from different countries and to promote intercultural dialogue through art. The exhibition will show how cultural diversity inspires artistic creativity and brings people together.

2. OBJECTIVES OF THE EXHIBITION

- Promoting artistic talents of children, youth and adults.
- Supporting international cultural cooperation.
- Showing the beauty of cultural diversity through art.
- Developing creativity and imagination of participants.

4. THEME OF THE ARTWORKS

Main theme: **Talents Together – Colors of Diversity**

The artworks may present:

- Cultural diversity of the world
- Friendship between nations
- Traditions of different countries
- Colors as a symbol of emotions and cultures
- Talents of people from different backgrounds
- Living together in a diverse world

The interpretation of the theme is open and depends on the author's imagination.

5. PARTICIPATION CONDITIONS

- The exhibition is open to children, youth and adults from all over the world.
- Each participant may submit a maximum of one artwork.
- One teacher, instructor or art supervisor may submit a maximum of 5 participants.
- All artworks must be original and created independently.
- Participation in the exhibition is free of charge.
- Artworks must be submitted in electronic form.

6. SUBMISSION OF ARTWORKS

- Technical requirements:
 - JPG or PNG format
 - minimum 3000 px on the longer side
 - good image quality
- Submission deadline: **September 25, 2026**

7. SELECTION OF ARTWORKS

- a. The organizers will select artworks for the exhibition based on the following criteria:
- interpretation of the exhibition theme
 - technical level
 - originality and creativity
 - artistic expression
 - emotional impact
 - overall artistic impression
- b. Technical level is not the only selection criterion. Artworks that strongly reflect the exhibition theme may also be selected.
- c. The decision of the organizers is final and not subject to appeal.
- d. Each participant will receive an electronic **Certificate of Participation**.
- e. Authors of artworks selected for the exhibition will receive a **Distinction Certificate**.
- f. The organizer reserves the right to limit the number of artworks submitted by one institution.

8. PRESENTATION OF ARTWORKS

- a. The exhibition of selected artworks will take place in Świdnica.
- b. The organizer has the right to use the artworks for promotional purposes of the exhibition and other events (with the author's name indicated).

9. TECHNIQUES

- drawing
- painting
- graphic art
- collage
- photography
- mixed techniques

10. COPYRIGHT AND IMAGE RIGHTS

- a. By submitting an artwork, the participant (or parent/legal guardian in the case of minors) confirms that the work is original and does not violate third-party rights.
- b. The author retains full copyright to their artwork.
- c. Submission of the artwork grants the organizer a free, non-exclusive right to use images of the artwork for the following purposes:
- organization of the exhibition
 - promotion of the event
 - publication on social media
 - publication on websites
 - educational and cultural activities
- d. The organizer agrees to always provide the author's name.
- e. No financial compensation is provided for the use of submitted artworks.

11. PARENTAL / LEGAL GUARDIAN CONSENT (MINORS)

- a. For participants under 18 years of age, submission must be made by a parent, legal guardian or teacher.
- b. Submission of the artwork means that the parent or legal guardian agrees to:
 - the child's participation in the exhibition
 - processing of personal data
 - publication of the artwork
 - publication of the author's name
- c. The organizer may request additional confirmation of consent if necessary.

12. ACCEPTANCE OF THE REGULATIONS

- a. Submission of an artwork means acceptance of these regulations.
- b. The organizer reserves the right to make changes to the regulations and will inform participants about any modifications.

13. PERSONAL DATA PROTECTION

- a. The administrator of personal data is Foundation "Inicjatywa" (Świdnica, Poland).
- b. Personal data will be processed exclusively for the purpose of organizing the exhibition.
- c. Participants have the right to access, correct and delete their personal data.

14. FINAL PROVISIONS

These regulations are valid from the date of publication.



Code of Conduct for Working with Children and Youth (Fundacja Inicjatywa)

We work with children and young people of different ages, cultures, languages and life experiences, including children with migration and refugee backgrounds.

Our priority is the safety, respect and well-being of the child.

-  **Safety** – physical, emotional and psychological.

Physical contact is allowed only when necessary (for example in situations involving health risks) and with the consent of the child/parent.

-  **Understanding and respect in communication** – we do not shout, humiliate or shame.

Rules are explained calmly and respectfully.

-  **Right to play and self-expression** – play is important for development and integration.

We support the child's creative expression.

-  **Equality and inclusion** – all children are equal regardless of language, culture, gender, religion or nationality. No one is favored or discriminated against.

INFORMATION CLAUSE ON PERSONAL DATA PROCESSING (GDPR)

According to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation – GDPR), we inform that:

1. The administrator of your personal data is Foundation "Inicjatywa", Świdnica, Poland, address: ul. Kotlarska 16/2, 58-100; NIP: 8842751099.

3. Your personal data will be processed for the purpose of organizing and conducting the exhibition "**Talents Together – Colors of Diversity**", including evaluation of artworks, communication with participants and promotion of the event.
4. The legal basis for processing personal data is consent (Art. 6(1)(a) GDPR) and legitimate interest (Art. 6(1)(f) GDPR), such as cultural and artistic promotion.
5. Personal data will be stored for the period necessary to achieve the purposes for which they were collected and for the period required by law.
6. You have the right to access your personal data, correct it, delete it or restrict processing, the right to data portability, the right to object to processing, and the right to withdraw consent at any time.
7. You have the right to file a complaint with the President of the Personal Data Protection Office if you believe your personal data is being processed unlawfully.
8. Providing personal data is voluntary but necessary to participate in the exhibition.
9. Personal data will not be transferred to third countries or international organizations.
